## **Ameresco to Announce Fourth Quarter and Full Year Financial Results on March 18, 2013**

FRAMINGHAM, Mass.--(BUSINESS WIRE)-- Ameresco, Inc. (NYSE:AMRC), a leading energy efficiency and renewable energy company, today announced that it will release its fourth quarter and full year 2012 financial results before the market opens on Monday, March 18, 2013. The Company will host its previously postponed earnings conference call at 8:30 a.m. ET the same day.

On the call, President and Chief Executive Officer George Sakellaris and Vice President and Chief Financial Officer Andrew Spence will discuss Ameresco's financial results, including resolution of its previously reported non-operating, non-cash change in hedge accounting treatment, as well as business outlook and strategy.

These prepared remarks will be furnished on a Current Report on Form 8-K and also posted to the "Investor Relations" section of the Company's website. This process is designed to provide investors and analysts with enhanced access to financial results, including GAAP and non-GAAP financial metrics, as well as additional insight into the Company's performance in advance of its earnings conference call. The Company also plans to file its Annual Report on Form 10-K for the year ended December 31, 2012 on Monday March 18<sup>th</sup>, including additional information on the effects of correcting its previously disclosed determination regarding hedge accounting treatment of an interest rate swap.
