Subject: California Proposition 65

To Whom it May Concern:

As a seller or distributor of product in the State of California, you may be aware of the requirements under California's Proposition 65, officially known as the Safe Drinking Water and Toxic Enforcement Act of 1986 ("Prop 65"). Prop 65 is administered by the Office of Environmental Health Hazard Assessment ("OEHHA"). Prop 65 prohibits manufacturers, distributers and retailers of consumer products sold in California from knowingly and intentionally exposing an individual to chemicals known to cause cancer or birth defects without first providing a "clear and reasonable warning." To be clear, Prop 65 does not ban or restrict the sale of chemicals that are on the list, nor does Prop 65 require a warning label if a listed chemical is simply contained in the product. The warnings are intended to help California consumers make informed decisions about potential exposures to chemicals contained in the products they use. Information about Prop 65 and its "clear and reasonable warning" requirements can be found at www.p65warnings.ca.gov.

Cliffs Steel Inc. ("Cliffs") records indicate that you have purchased one or more of the products listed in the chart below. As a manufacturer of these products, Cliffs is obligated to evaluate OSHA related chemical workplace and handling exposures related to the manufacture of these products, and when certain chemical thresholds exist, produce Safety Data Sheets (SDSs) for those products. This is not the same inquiry that is required for Prop 65 purposes.

Nevertheless, we wanted to alert you that the products listed below contain chemicals currently on the list of *Chemicals Known to the State to Cause Cancer or Reproductive Toxicity* (as of December 29, 2023). SDS references are included for these products although only chemicals triggering disclosure under OSHA Hazard Communication requirements are included on the SDSs and there may be other chemicals contained in these products in trace amounts. These products contain or may contain detectable chemicals which the State of California has found to cause cancer, birth defects or other reproductive harm.

Additional manufacturing incorporating these products, including use of the product to manufacture consumer products, is not contemplated in the Cliffs' SDSs. Accordingly, additional analysis by customers using these products to manufacture consumer products may be required for determining Prop 65 compliance.
