The Company is currently testing PAS-004 in a Phase 1 clinical trial in advanced cancer patients ([NCT06299839](#)), and a Phase 1/1b clinical trial in adult patients with neurofibromatosis type 1 (NF1)-associated plexiform neurofibromas ([NCT06961565](#)).
