# WisdomTree Reports Monthly Metrics for June 2025

*Record Month-End Assets Under Management Over \$6.5 Billion of Year-to-Date Net Inflows*

NEW YORK--(BUSINESS WIRE)-- WisdomTree, Inc. (NYSE: WT), a global financial innovator, today released monthly metrics for June 2025, including assets under management (AUM) and flow data by asset class.

## Monthly Commentary:

- Record month-end AUM of over \$126 billion, including record highs in each of the U.S., Europe and Digital Assets business lines
- Over \$6.5 billion of year-to-date net inflows, translating to approximately 12% annualized organic growth, with over \$1.4 billion of net inflows added in June alone
- Net inflows in seven of WisdomTree's eight product categories in Q2, underscoring the breadth and resilience of the firm's diversified platform
- Digital Assets business delivered \$105 million of net inflows in June, bringing 1H25 net inflows to \$317 million, with a robust pipeline for both July and the remainder of 2025
