Engineering and Logistics Services to Be Performed at Tobyhanna and Red River Army Depots

ALEXANDRIA, Va.-- VSE Corporation (Nasdaq GS:VSEC) reported today that its Federal Group was awarded two new Department of Defense contracts.

Tobyhanna Army Depot (TAD) Shelter Refurbishment

VSE's Engineering and Logistics Division was awarded a \$10 million contract from Tobyhanna Army Depot to refurbish Army S-280 and S-250 Equipment Shelters, which are lightweight, high strength, insulated all-weather shelters that satisfy general purpose applications for housing communications and other transportable electronic equipment. Refurbishment services to be provided by VSE include inspection, repair, sealing, blasting, painting and testing of Equipment Shelters.

Fuel Tanker Sealant System Spray (FTSS) Application

VSE'S Engineering and Logistics Division was awarded a \$2 million contract from Red River Army Depot (RRAD) to repair 68 of the Army's fleet of 5,000-gallon fuel tankers previously coated with the Fuel Tanker Self Sealant System (FTSS). In support of this TACOMmandated effort accelerated by the Department of the Army, VSE will partner with RRAD to blast, paint and repair the tanker frames in addition to repairing damaged tanker bodies with FTSS coating.
