

VSE Corporation Receives \$42M in New Awards

ALEXANDRIA, Va.-- VSE Corporation (NASDAQ: VSEC) reported awards received from December 1, 2015 to date totaling approximately \$42.2 million. The recent awards include:

- Red River Army Depot (RRAD) M915A3 Remanufacture
 VSE will provide labor, parts, facilities, management, transportation, tooling, and equipment to remanufacture up to 175 M915A3 trucks provided by Red River Army Depot (RRAD). The work will be performed at VSE facilities in Texarkana, Arkansas. The firm-fixed-price award has a period of performance of 12 months and total award of up to \$23M.
- Egyptian Navy In-Country Technical Assistance and Support
 VSE will provide Follow-On Technical Support (FOTS) for the OSPREY Class Mine
 Hunter Coastal (MHC) Vessels, including level-of-effort technical, logistics, training,
 facilities, and administrative support to NAVSEA PMS 326 and the Egyptian Navy's two
 (2) MHC ships. This is a delivery order under our Foreign Military Sales (FMS) Naval
 Ship Transfer and Repair (N*STAR) contract through the Naval Sea Systems
 Command (NAVSEA) International Fleet Support Program. The delivery order has a
 period of performance of 12 months and total funded value of \$15.2M.

• Patrol Boats Engineering Service Support

VSE will provide engineering and material support during the overhaul of counternarcotics patrol boats in El Salvador and Guatemala. This is a delivery order in support of PMS 325 under our Foreign Military Sales (FMS) Naval Ship Transfer and Repair (N*STAR) contract through the Naval Sea Systems Command (NAVSEA) International Fleet Support Program. The delivery order has a period of performance of 12 months and a total funded value of \$4M.

"We are closing our calendar year with several new awards in support of our traditional federal customers," said Maurice "Mo" Gauthier, VSE CEO, President and COO. "These awards, in addition to previously announced awards, result in a higher backlog entering 2016."
