"This generous gift from ExxonMobil will serve to further our mission to give stability and hope to children and their families, especially at this time of the holidays," said Dr. Wayne Carson, CEO, ACH Child and Family Services. "We are deeply appreciative of this donation as we look forward to another century of making a difference."

ExxonMobil established the holiday gift in 2006 to support North Texas nonprofit agencies during the holiday season.
