Old Dominion Freight Line Signs Definitive Agreement to Purchase Assets of Priority Freight Lines

Transaction to Expand Service Center Network and Enable Launch of Full-State Coverage in Washington

THOMASVILLE, N.C.--(BUSINESS WIRE)--

Old Dominion Freight Line, Inc. (NASDAQ: ODFL) today announced a definitive agreement to purchase selected assets of Priority Freight Lines, headquartered in Sumner, Washington. Priority Freight Lines produced revenue of approximately \$17 million for the year ended December 31, 2006, through its network of eight owned and leased service centers located in Washington, Oregon, Idaho and Utah. Old Dominion plans to operate three of these service centers located in Yakima and Pasco, Washington and Medford, Oregon and consolidate the remainder of Priority's operations with its existing network of 184 service centers. By the end of April 2007, Old Dominion expects to complete the transaction, which includes the purchase of revenue equipment, accounts receivables, office equipment, IT systems and one service center facility.

Earl E. Congdon, Chairman and Chief Executive Officer of Old Dominion, remarked, "Priority Freight Lines is a well-run company with a strong franchise in its four-state market and has built an excellent reputation for providing quality transportation service. With this acquisition, we will launch full-state coverage in Washington, our 38th state with full-state coverage, and enhance our direct coverage in Oregon. This transaction is consistent with our growth and service strategies and is also in keeping with our focus of expanding and improving our multi-regional and inter-regional network."
