With this new capability, Exterro users will be able to click a button and send their audio and video files to Veritone Redact for redaction. Once these files have been redacted, the user can ingest them with full chain of custody information back into the Exterro platform to complete their e-discovery, privacy and digital forensics workflow. Veritone Redact and its suite of public safety AI solutions are currently being licensed and used by over 275 public safety and justice agencies across the United States.
