# WisdomTree Reports Monthly Metrics for May 2025

*Record Month-End Assets Under Management Over \$5.1 Billion of Year-to-Date Net Inflows*

NEW YORK--(BUSINESS WIRE)-- WisdomTree, Inc. (NYSE: WT), a global financial innovator, today released monthly metrics for May 2025, including assets under management (AUM) and flow data by asset class.

## Monthly Commentary:

- Record month-end AUM of over \$121.5 billion, our 10th month-end record in the past 12 months
- Model portfolios business reached \$5.0 billion in assets under advisement (AUA), a new milestone
- Record-setting month for the WisdomTree Europe Defence UCITS ETF (WDEF):
  - \$680 million in May inflows and \$2.1 billion year-to-date, making it one of the most successful product launches in WisdomTree's history
  - Products focusing on protecting clients from global political risks are expanding beyond WDEF with the WisdomTree European Equity Opportunity Fund (OPPE) and upcoming global product launches
- Digital Assets business delivered \$110 million in net inflows in May, bringing year-to-date inflows to \$212 million — a record high for tokenized AUM on the WisdomTree platform, with a robust pipeline for the rest of 2025
- Over \$5.1 billion of year-to-date net inflows, translating to approximately 11% annualized organic growth, with nearly \$2.0 billion added in May
- All eight of WisdomTree's product categories contributed to net inflows in May, underscoring the breadth and resilience of the firm's diversified platform
