TALLAHASSEE, Fla., Nov. 19, 2020 (GLOBE NEWSWIRE) -- The Board of Directors of Capital City Bank Group, Inc. (NASDAQ: CCBG) declared a quarterly cash dividend on its common stock of \$.15 per share. It represents a 7.1% increase over the prior quarter of \$.14. The dividend produces an annualized rate of \$.60 per common share and is payable on December 21 to shareowners of record as of December 7, 2020. The annualized dividend yield is 2.59% based on a closing stock price of \$23.20 on November 18, 2020.
