

## Ingram Micro Announces Filing of Registration Statement for Proposed Initial Public Offering

IRVINE, Calif.--(BUSINESS WIRE)-- Ingram Micro Holding Corporation ("Ingram Micro") today announced that it has filed a registration statement on Form S-1 with the U.S. Securities and Exchange Commission (the "SEC") relating to the proposed initial public offering of shares of its common stock (the "Common Stock"). Certain of Ingram Micro's existing stockholders identified in the registration statement are also expected to sell shares of Common Stock in the proposed offering. The number of shares to be offered and the price range for the proposed offering have not yet been determined. The offering is subject to market conditions, and there can be no assurance as to whether or when the offering may be completed, or as to the actual size, price or other terms of the offering.

Ingram Micro intends to list its Common Stock on the New York Stock Exchange under the ticker symbol "INGM."

Morgan Stanley, Goldman Sachs & Co. LLC and J.P. Morgan are acting as joint book-running managers for the proposed offering and as representatives of the underwriters for the proposed offering. BofA Securities, Deutsche Bank Securities, Evercore ISI, Jefferies and RBC Capital Markets are acting as bookrunners for the proposed offering. BNP PARIBAS, Guggenheim Securities, Raymond James, Rothschild & Co, Stifel, William Blair, Fifth Third Securities and Loop Capital Markets are acting as co-managers for the proposed offering.
