W&T Offshore, Inc. is an independent oil and natural gas producer with operations offshore in the Gulf of America and has grown through acquisitions, exploration and development. The Company currently has working interests in 48 producing fields in federal and state waters and has under lease approximately 591,000 gross acres in the Gulf of America, including approximately 455,000 gross acres on the conventional shelf and approximately 136,000 gross acres in the deepwater. A majority of the Company's daily production is derived from wells it operates.
