FIBRA Prologis Declares Quarterly Distribution

MEXICO CITY, Oct. 19, 2022 /PRNewswire/ -- FIBRA Prologis (BMV:FIBRAPL 14), a leading owner and operator of Class-A industrial real estate in Mexico, declared today a cash distribution of Ps. 605.3 million (US\$30.3 million), or Ps. 0.5997 per *Certificado Bursátil Fiduciario Inmobiliario* ("CBFI") (US\$ 0.0300 per CBFI) related to the results of the third quarter ending September 30, 2022.

The distribution is payable October 28, 2022 to CBFI holders with an ex-dividend date of October 26, 2022, and a record date of October 27, 2022.

FIBRA Prologis is a leading owner and operator of Class-A industrial real estate in Mexico. As of September 30, 2022, FIBRA Prologis was comprised of 228 logistics and manufacturing facilities in six industrial markets in Mexico totaling 43.4 million square feet (4.0 million square meters) of gross leasable area.
