Summit Wireless and our customers plan to showcase and launch WiSA-ready products, including speakers for game consoles and TVs, at CES, which takes place in Las Vegas, January 2019. We believe the growing WiSA membership and the accelerating Summit Wireless integration by more leading brands will create significant long-term revenue growth opportunities,” concluded Moyer.
