Lighthouse is particularly well suited for upgrading existing 4G Distributed Antenna System (DAS) deployments to 5G, allowing enterprises to extend next-generation coverage leveraging existing infrastructure while significantly reducing deployment complexity, accelerating time-to-service, and lowering the total cost of ownership, compared to traditional solutions.

"With Lighthouse, we're delivering a fundamentally better way for enterprises to extend 5G coverage indoors and outdoors—without ripping and replacing existing infrastructure," said Brian Makarowski, Vice President of Product Management and Marketing at Airgain.
