

Boardwalktech Closes Additonal Tranche of Upsized Non-Brokered Private Placement

CUPERTINO, Calif., Feb. 4, 2021 /CNW/ - (TSXV: BWLK) (OTCQB: BWLKF) — Boardwalktech Software Corp. ("Boardwalktech" or the "Company"), a leading digital ledger platform and enterprise software solutions provider, is pleased to announce it has closed an additional tranche of its previously announced, upsized non-brokered private placement (the "Non-Brokered Offering").

This second tranche of the Non-Brokered Offering consisted of 1,000,000 additional units of the Company (each, a "Unit", and collectively the "Units") at a price of C\$0.70 per Unit (the "Offering Price") for gross proceeds of approximately C\$700,000, which increases aggregate proceeds from the Non-Brokered Offering to C\$1,078,000. Each Unit consists of one common share (each, a "Common Share", and collectively the "Common Shares") and one-half of one Common Share purchase warrant (each whole warrant, a "Warrant", and collectively the "Warrants"). Each Warrant entitles the holder thereof to acquire one Common Share at a price of C\$0.90 per Common Share for a period of 24 months from the issuance date thereof.

The Company will use the net proceeds of the Non-Brokered Offering for repayment of existing debt, sales and marketing expenditures, working capital requirements, and general corporate purposes.

The securities issued on completion of the Non-Brokered Offering will be subject to a hold period of four (4) months and one day from the date of issuance. The Non-Brokered Offering is subject to the final approval of the TSX Venture Exchange.
