GREENWOOD VILLAGE, Colo.--(BUSINESS WIRE)-- National Storage Affiliates Trust ("NSA" or the "Company") (NYSE: NSA), announced that its Board of Trustees today declared regular cash dividends for the first quarter 2023 payable on March 30, 2023 to shareholders of record on March 15, 2023 on the following securities:

- a dividend of \$0.55 per common share, representing an annualized dividend rate of \$2.20; and
- a dividend of \$0.375 per share on the Company's 6.000% Series A Cumulative Redeemable Preferred Shares.
