GREENWOOD VILLAGE, Colo.--(BUSINESS WIRE)-- National Storage Affiliates Trust ("NSA" or the "Company") (NYSE: NSA), announced that its Board of Trustees today declared regular cash dividends for the second quarter 2025 payable on June 30, 2025 to shareholders of record on June 13, 2025 on the following securities:

- a dividend of \$0.57 per common share, representing an annualized dividend rate of \$2.28; and
- a dividend of \$0.375 per share on the Company's 6.000% Series A Cumulative Redeemable Preferred Shares; and
- a dividend of \$0.375 per share on the Company's 6.000% Series B Cumulative Redeemable Preferred Shares.
