

## SDI Awarded State Penitentiaries Correctional Services Contract

TAMPA, Fla.--(BUSINESS WIRE)-- (TSX-V:SDZ) (OTCBB:SDEV) Security Devices International Inc. ("SDI" or "the Company") today announced that it has been awarded a solicitation-bid contract or Agency Request for Quotation (ARFQ) for a State-Wide use of its products.
