Ondas Secures Strategic Defense Contract in Asia-Pacific as Part of Its Global Expansion

New contract expands Ondas' geographic and defense footprint in the Asia-Pacific (APAC) region

Reinforces growing demand for autonomous UAS capabilities with governmental entities in APAC

The award supports the deployment of Ondas' autonomous unmanned aerial capabilities for national security missions. The contract is expected to be executed over multiple phases, with initial deliveries beginning this year and potential follow-on orders anticipated as deployments expand.

"We are announcing this new contract during the [Singapore Airshow this week](#), reflecting the accelerating demand we are seeing across the Asia-Pacific region for mission-ready autonomous defense systems," said Eric Brock, Chairman and CEO of Ondas Holdings. "Governments in the region are responding to a rapidly evolving threat environment, particularly for borders, critical infrastructure, and sensitive national assets. Our autonomous platforms are purpose built for these challenges, delivering persistent protection, rapid response, and operational resilience in complex and contested environments."

The contract is anchored by the integration of Ondas' autonomous systems within existing defense and security architectures, enabling new tactical unmanned aerial capabilities uniquely offered by Ondas.

"The contract reflects OAS' commitment to our Asia-Pacific defense customers," said Oshri Lugassy, Co-CEO of Ondas Autonomous Systems. "Our platforms are differentiated by their maturity, combat proven performance, and the ability to be customized to meet specific operational and tactical requirements of our customers."

The new award builds on Ondas' expanding presence in Asia-Pacific and aligns with the Company's broader global strategy to scale deployments across defense, homeland security, and public safety markets. Over the past year, Ondas has increased its engagement with governmental customers across the region, supporting programs focused on border security, critical infrastructure protection, and counter drone operations.

The contract further reinforces Ondas' global momentum as an emerging defense

technology prime contractor, executing its roadmap to deliver integrated, autonomous solutions across air and ground domains. The Company continues to invest globally in localized production capacity, field support, and regional partnerships to address growing international demand and support for long-term program expansion.
