These contributions and pledges reflect BD's Social Investing philosophy, which involves formulating and executing strategic initiatives with community partners to create healthier communities worldwide, demonstrate BD's social responsibility, and build relationships in support of BD's corporate goals. The primary objectives are to:

- Align and concentrate on healthcare programs and initiatives that address key issues in communities where BD
 has operations, and where its core competencies and resources can be leveraged most effectively; and
- Support programs where BD maintains facilities or has a significant presence to apply local BD resources to local community needs.

BD aligns its giving under four pillars:

- Build accessible, resilient and sustainable health systems
- Expand and strengthen the healthcare workforce
- Support detection/treatment of cancer and chronic disease in diverse, lower/middle income communities
- Disaster preparedness and relief
