## **PNC Declares Dividend of 63 Cents on Common Stock**

PITTSBURGH, July 5 /PRNewswire-FirstCall/ -- The PNC Financial Services Group, Inc. (NYSE: PNC) today announced that the board of directors declared a quarterly cash dividend of 63 cents per share on the common stock. The dividend is payable July 24, 2007 to shareholders of record at the close of business July 13, 2007.

The board also declared a quarterly cash dividend on the following preferred stocks:

- Series A and B: a dividend of 45 cents per share will be payable Sept. 10, 2007 to shareholders of record at the close of business Aug. 17, 2007.
- Series C: a dividend of 40 cents per share will be payable Oct. 1, 2007 to shareholders of record at the close of business Sept. 7, 2007.
- Series D: a dividend of 45 cents per share will be payable Oct. 1, 2007 to shareholders of record at the close of business Sept. 7, 2007.
