Rexford Industrial Announces Launch Of Common Stock Offering

LOS ANGELES, May 11, 2020 /PRNewswire/ -- Rexford Industrial Realty, Inc. (the "Company" or "Rexford Industrial") (NYSE: REXR), a real estate investment trust focused on creating value by investing in and operating industrial properties located in Southern California infill markets, today announced that it has commenced an underwritten public offering of 6,250,000 shares of its common stock. The Company expects to grant the underwriters a 30-day option to purchase up to an additional 937,500 shares of common stock at the public offering price, less the underwriting discount.

The Company intends to contribute the net proceeds from this offering to its operating partnership, which intends to use the net proceeds from the offering to fund future acquisitions, fund development or redevelopment activities and for general corporate purposes.

Goldman Sachs & Co. LLC, J.P. Morgan and BofA Securities are acting as joint bookrunning managers of this offering.

This offering is being made pursuant to an effective shelf registration statement and prospectus and related preliminary prospectus supplement filed by the Company with the Securities and Exchange Commission.
