It represents a 3.85% increase over the prior quarter dividend of \$0.26 per share. The dividend produces an annualized rate of \$1.08 per common share and is payable on March 23, 2026, to shareowners of record as of March 9, 2026. The annualized dividend yield is 2.48% based on a closing stock price of \$43.56 on February 25, 2026.
