Mueller Industries, Inc. Declares Cash Dividend for First Quarter

(NYSE: MLI), announced today that its Board of Directors has declared a regular quarterly dividend of 10 cents per share on its common stock. The dividend will be payable March 15, 2012, to shareholders of record on March 1, 2012.
