Mueller Industries, Inc. Announces Intent to Redeem its 6% Subordinated Debentures

(NYSE: MLI), announced today that it issued a Notice of Redemption to all the holders of its 6% Subordinated Debentures (the Debentures). The Debentures will be redeemed at par value totaling approximately \$148.2 million principal and accrued interest totaling approximately \$1.3 million. The redemption will occur on or about June 25, 2012.
