The surveys are reviewed and developed by the independent Military Friendly Advisory Council.

"As a veteran working for Maximus, it's very rewarding to see our company recognized for our efforts with veterans," said Dr. Michael Weiner, Chief Medical Officer, Maximus, who graduated from the Naval Academy, served in the Navy, and was Chief Medical Officer of the global Navy Expeditionary Combat Command.
