Partnering with these leading laboratories makes available a new network of close to 4,000 additional in-network clinics for candidates and clients.

After selecting a clinic, candidates and employees will receive an automated requisition they can take with them to the clinic, eliminating the need to visit a third-party clinic to obtain a physician's referral.

As part of the integration, our major commercial laboratory partners transmit results directly to the HireRight screening platform.
