# COPT Declares Fourth Quarter 2011 Dividends

COLUMBIA, Md.--(BUSINESS WIRE)-- Corporate Office Properties Trust (COPT) (NYSE: OFC), a specialty office real estate investment trust (REIT) that focuses primarily on serving the specialized requirements of U.S. Government and Defense Information Technology tenants, announced today that its Board of Trustees has declared a quarterly dividend of \$0.4125 per Common Share of beneficial interest for the fourth quarter 2011. The dividend will be paid on January 17, 2012 to shareholders of record on December 31, 2011.

For the Preferred Shares of beneficial interest of the Company, listed below, the Board of Trustees declared dividends for the period commencing October 15, 2011 and ending January 14, 2012, payable on January 17, 2012 to shareholders of record on December 31, 2011.

COPT is a specialty office REIT that focuses primarily on strategic customer relationships and specialized tenant requirements in the U.S. Government and Defense Information Technology sectors and Data Centers serving such sectors. The Company acquires, develops, manages and leases office and data center properties that are typically concentrated in large office parks primarily located adjacent to government demand drivers and/or in strong markets that we believe possess growth opportunities. As of September 30, 2011, the Company owned 266 office properties totaling 21.3 million rentable square feet, which includes 20 properties totaling 1.1 million square feet held through joint ventures. The Company's portfolio primarily consists of technically sophisticated buildings in visually appealing settings that are environmentally sensitive, sustainable and meet unique customer requirements.
