

COPT Signs 1 MW Lease at Data Center

COLUMBIA, Md.--(BUSINESS WIRE)-- Corporate Office Properties Trust (COPT) (NYSE: OFC) recently completed a new lease with a high-growth commercial colocation provider at COPT's DC-6 data center in Manassas, Virginia. The tenant has an initial commitment of one megawatt (MW), plus opportunities for expansion. With this one MW commitment, four of the data center's 18 potential MWs are committed, which increases the percentage leased from 17% at June 30, 2012 to 22%.

"We are pleased to complete this new lease at COPT DC-6," commented Roger A. Waesche, Jr., President & Chief Executive Officer of COPT, "and believe it validates the rebranding and marketing efforts recently launched with respect to the asset."

COPT is an office real estate investment trust (REIT) that focuses primarily on strategic customer relationships and specialized tenant requirements in the U.S. Government and Defense Information Technology sectors and Data Centers serving such sectors. The Company acquires, develops, manages and leases office and data center properties that are typically concentrated in large office parks primarily located adjacent to government demand drivers and/or in strong markets that it believes possess growth opportunities. As of June 30, 2012, COPT's consolidated portfolio consisted of 228 office properties totaling 19.8 million rentable square feet. The Company's portfolio primarily consists of technically sophisticated buildings in visually appealing settings that are environmentally sensitive, sustainable and meet unique customer requirements.
