

COPT Declares First Quarter 2015 Dividends

COLUMBIA, Md.--(BUSINESS WIRE)-- The Board of Trustees of Corporate Office Properties Trust ("COPT" or the Company) (NYSE: OFC) declared a quarterly dividend of \$0.275 per Common Share of beneficial interest for the first quarter 2015, payable on April 15, 2015, to shareholders of record on March 31, 2015.

For the Series K and L Preferred Shares of beneficial interest of the Company listed below, the Board of Trustees declared dividends for the period commencing January 15, 2015, and ending April 14, 2015, payable on April 15, 2015, to shareholders of record on March 31, 2015.

Company Information

COPT is an office REIT that focuses primarily on serving the specialized requirements of U.S. Government agencies and defense contractors, most of which are engaged in defense information technology and national security-related activities. As of December 31, 2014, COPT derived 77% of its annualized revenue from its strategic tenant niche properties and 23% from its regional office properties. The Company generally acquires, develops, manages and leases office and data center properties concentrated in large office parks primarily located near knowledge-based government demand drivers and/or in targeted markets or submarkets in the Greater Washington, DC/Baltimore region. As of December 31, 2014, the Company's consolidated office portfolio consisted of 173 office properties totaling 16.8 million rentable square feet. COPT is an S&P MidCap 400 company.
