When Walters asked how she'd want her epitaph to read, Taylor replied, "Here lies Elizabeth. She hated being called Liz. Oprah Winfrey's classic interviews with Taylor from "The Oprah Winfrey Show": On Elizabeth Taylor's first appearance on "The Oprah Winfrey Show" from February 1, 1988 Oprah sits down with Taylor to discuss her marriage to Senator John Warner and her book *Elizabeth Takes Off*. Taylor's second appearance on the Oprah show was on March 4, 1992.
