Membership in the Russell 3000 Index, which remains in place for one year, means automatic inclusion in the large-cap Russell 1000® Index or small-cap Russell 2000® Index, as applicable, as well as the appropriate growth and value style indexes. FTSE Russell determines membership for its Russell indexes primarily by objective, market-capitalization rankings and style attributes.

"We are thrilled to be added to the Russell 3000 Index, which is the first significant milestone for P3 Health Partners as a public company, as it will increase visibility and liquidity for our shareholders," said Dr. Sherif Abdou, P3's Founder and CEO.
