

PUBLIC POLICY ADVOCACY POLICY

1. PURPOSE

Kodiak Gas Services, Inc., a Delaware corporation, and its subsidiaries, (collectively, the "Company"), actively participate in public policy advocacy at the federal, state or local level. The Company's government relations initiatives consist of partnering with industry participants and trade associations with shared interests or concerns and intended to educate and inform officials and the public on a broad range of public policy issues in furtherance of its business objectives. These initiatives are not based on the personal agendas of individual directors, officers, or employees of the Company.

2. APPLICABILITY

This Public Policy Advocacy Policy (this "<u>Policy</u>") is applicable to the Company's operations worldwide. The Company's public activities are conducted in accordance with the standards articulated in the Company's Code of Conduct. This Policy applies to all of the Company's directors, officers, and employees, joint venture partners, and any other third-party representatives that, on behalf of the Company, have conducted business or interacted with government officials or are likely to conduct business or interact with government officials.

3. POLITICAL CONTRIBUTIONS

The Company does not make contributions from Company funds to foreign, federal, state or local candidates, political parties, political action committees, or 527 organizations. Neither the Company nor its employees shall use the Company's resources for contributions to candidates, political parties, or 527 organizations, or to influence state or local ballot initiatives or political action committees, whether at the foreign, federal, state or local level, even when permitted to do so by applicable laws.

4. PUBLIC POLICY ADVOCACY

The Company is committed to being a responsible corporate citizen and an effective participant in the legislative and regulatory processes. Our business is subject to extensive laws at the federal, state and local levels, and changes to such laws can significantly impact how we operate and how we can serve our stakeholders, including the jobs we can create in the communities in which we operate, the compensation we can pay our employees, the services we can provide our customers and the returns we can provide our shareholders. Accordingly, we believe it is important to understand and engage in public policy matters that are applicable

to our business, which may include the engagement of specialized outside legal counsel and consultants.

5. TRADE ASSOCIATIONS

As part of our engagement in the public policy process, the Company participates in certain trade associations and industry groups and pays membership dues to certain trade associations. The Company may not always support every position taken by these organizations or their members. However, we believe membership in these organizations can provide a number of benefits including, facilitating the Company's ability to stay abreast of technical issues and emerging industry standards; providing educational opportunities for employees; supporting workforce development initiatives; reporting on trends relevant to the Company's business; and engaging in public advocacy and education on behalf of the membership. Some trade associations utilize a portion of membership dues for non-deductible lobbying regarding issues of common concern to members. Under IRC Section 6033(e)(1), trade associations are required to inform contributors of the portion of annual dues, if any, attributable to lobbying expenses. The Company does not make payments to trade associations or other tax-exempt organizations that are designated for political or election-related purposes. In the event that the Company makes such a payment in the future, it would publicly disclose that information.

The Company annually reviews its trade association memberships to ensure they continue to serve the Company's business needs. Any decision to join or withdraw from a trade association must be approved by the Company's Executive Vice President and Chief Legal Officer. For additional guidance concerning participation in trade associations and related antitrust risks, see the Company's Code of Conduct and Antitrust Compliance Policy.

6. POLITICAL ACTION COMMITTEES

The Company currently does not have a political action committee. The formation of any political action committees by the Company must be approved by the Nominating, Governance & Sustainability Committee of the Company's Board of Directors (the "NGS Committee").

7. PAYMENT, REPORTING AND ACCOUNTING

Approval to engage in the aforementioned types of advocacy must be granted by the Executive Vice President and Chief Financial Officer or the Executive Vice President and Chief Legal Officer. Approval of payments should adhere to all related Company policies and our approval matrices.

The Company's public policy advocacy efforts that could have an impact on our tax status are reviewed quarterly by our Audit & Risk Committee. Our participation in trade associations and expenditures relating to such memberships are reviewed annually with the NGS Committee, which is entirely comprised of independent directors.
