Ameresco Expands Energy Efficiency and Demand Side Management Services for Utilities

(NYSE: AMRC) a leading energy efficiency and renewable energy company, announced today that it has acquired Applied Energy Group ("AEG"), a privately held company providing energy efficiency and demand side management consulting services.
