

Internally, Perimeter Solutions has taken steps to increase recycling, made capital investments to reduce the amount of energy used in its manufacturing process, and increased the use of e-records to reduce the Company's carbon footprint.
- Social Impact: Perimeter Solutions is committed to providing equal employment opportunities. All recruiting, payment, performance, and promotion decisions are based on merit, without discrimination on the basis of gender, sexual orientation, age, family status, ethnic origin, nationality, disability, or religious belief. Women represent approximately 19% of Perimeter Solutions' total workforce. Members with diverse backgrounds comprise 33% of the Company's Board. At the community level,

- Perimeter Solutions devoted 500,000 hours of dedicated service to forest fire remediation. The Company's focused on contributing to the creation of a better world through its strategic nonprofit partnerships, volunteerism, and philanthropy.
