#### MICRO-CAP IPO SUMMARY

The Micro-Cap IPO market broke records in October, having both the largest IPO count and dollars raised this year, with 20 issuers listing their shares on Nasdaq and NYSE, raising a combined \$238 million. The month of October alone almost totals the number of iPOs in 2023, with still 2 months to go!

Micro-Cap issuers who operate in 7 different sectors completed their IPOs in October, including from the industrials, healthcare, consumer, technology, communication, energy and financial sectors.

Offerings ranging from \$4,199,995 to \$75,020,000 were completed by Micro-Cap issuers, with investing banking partners including US Tiger Securities, Benchmark, Craft Capital, Cathay Securities, R.F. Lafferty, EF Hutton, ThinkEquity, Bancroft, Revere Securities, Aegis, Roth Capital, WestPark and Dominari.

One issuer offered a non-tradeable warrant in the IPO (PLRZ). Eighteen of the issuers listed on Nasdaq while two issuers listed on NYSE. Six of the issuers registered their legacy shareholders in the IPO's registration statement in order to meet Nasdaq's \$15 million public float requirement. The median offering size in was \$6.8 million.

Fifteen of the offerings were completed by foreign private issuers (FPIs) from the Cayman Islands (8), the British Virgin Islands (3), Singapore (1), China (1), Israel (1), and Australia (1).




















Twenty Micro-Cap IPOs were completed in October.
