

## Two-Time Masters Champion Ben Crenshaw Joins SiriusXM PGA TOUR Radio

"Crenshaw on Golf" will feature the World Golf Hall of Famer's musings on the game every other week starting Dec. 11

The two-time Masters winner will host *Crenshaw on Golf*, a one-hour show airing every other week on SiriusXM PGA TOUR Radio, with the first episode debuting Wednesday, December 11 at 1:00 pm ET. Crenshaw and co-host Ed Clements will talk about today's game and its players, share stories from Crenshaw's many years in the sport and discuss golf course design and his favorite venues around the world.

Among the many highlights of Crenshaw's distinguished career are his two victories in the Masters. He claimed his first, a two-stroke victory over Tom Watson in 1984, with a commanding performance on Sunday at Augusta. His second, in 1995, was perhaps the most emotional victory of his career, coming a week after the death of his mentor, Harvey Penick. Crenshaw won 19 tournaments during his career on the PGA TOUR and finished in the top ten 27 times in major tournaments. He played on the U.S. Ryder Cup team four times (1981, 1983, 1987, 1995). In 1999, he captained the U.S. team to one of the most remarkable comebacks in Ryder Cup history, when the Americans won 8 ½ of the final day's 12 points to win the event at The Country Club in Brookline, MA. Crenshaw was inducted into the World Golf Hall of Fame in 2002.

Today, Crenshaw competes on the Champions Tour and is a noted golf course designer. His

firm, Coore & Crenshaw, has built championship courses throughout the U.S. including Friar's Head on New York's Long Island, Bandon Trails in Bandon, Oregon, and the Sand Hills GC near Mullen, Nebraska.
