# David Letterman and Paul Shaffer Co-Host Apron Strings on SiriusXM's Outlaw Country with Elizabeth Cook

A self-professed fan of the channel, and particularly Cook's daily *Apron Strings* show, Letterman "invited himself" to co-host the special episode from the SiriusXM studios in New York, and brought along his long time musical director Paul Shaffer to share some of his favorite musical moments from the "*Late Show*" and discuss his new album, *Paul Shaffer & The World's Most Dangerous Band*.
