# Emmaus Life Sciences Receives Endari® Marketing Authorization from the Qatar Ministry of Public Health

## *Company Receives First Major Purchase Order in Saudi Arabia*

TORRANCE, Calif., Nov. 17, 2022 /PRNewswire/ -- **Emmaus Life Sciences, Inc.** (OTCQB: EMMA), a leader in sickle cell disease treatment, announced today that it has been issued a Registration Certificate from the Registration Committee for Pharmaceutical Companies & their Products of the Qatar Ministry of Public Health granting marketing authorization for the commercial distribution and sale of Endari® in the country. The company also announced that it received its first major purchase order from its distributor in the Kingdom of Saudi Arabia, where Endari® is available on an early access basis only.



Endari® is approved in the U.S., the United Arab Emirates, Israel, and the State of Qatar to reduce the acute complications of sickle cell disease in adult and pediatric patients five years of age and older. Endari® is available on an early access basis in Bahrain, Kuwait and the Kingdom of Saudi Arabia pending official notice of action on Emmaus's marketing authorization applications in those countries.

Dr. Yutaka Niihara, M.D., M.P.H., Chairman and Chief Executive Officer of Emmaus, commented "We are grateful that Qatari officials made access to Endari easier for the sickle cell patients in the country. We will continue to strive in our mission to afford increased availability of Endari in the Middle East and North Africa region with its large and underserved sickle cell disease patient population."

George Sekulich, Senior Vice President of Global Commercialization of Emmaus, added "The approval from the Ministry of Public Health is another validation of the safety and efficacy of Endari. We look forward to working with our distribution partner to make Endari available to the sickle cell disease patients in the emirate."

### **About Endari®** (prescription grade L-glutamine oral powder)

Indication - Endari® is indicated to reduce the acute complications of sickle cell disease in adult and pediatric patients five years of age and older.

### **Important Safety Information**

The most common adverse reactions (incidence >10 percent) in clinical studies were constipation, nausea, headache, abdominal pain, cough, pain in extremities, back pain, and chest pain.

Adverse reactions leading to treatment discontinuation included one case each of hypersplenism, abdominal pain, dyspepsia, burning sensation, and hot flash.

The safety and efficacy of Endari® in pediatric patients with sickle cell disease younger than five years of age has not been established.

### **About Sickle Cell Disease**

There are approximately 100,000 people living with sickle cell disease (SCD) in the United States and millions more globally. The sickle gene is found in every ethnic group, not just among those of African descent; and in the United States an estimated 1-in-365 African Americans and 1-in-16,300 Hispanic Americans are born with SCD.<sup>1</sup> The genetic mutation responsible for SCD causes an individual's red blood cells to distort into a "C" or a sickle shape, reducing their ability to transport oxygen throughout the body. These sickled red blood cells break down rapidly, become very sticky, and develop a propensity to clump together, which causes them to become stuck and cause damage within blood vessels. The result is reduced blood flow to distal organs, which leads to physical symptoms of incapacitating pain, tissue and organ damage, and early death.<sup>2</sup>
