The new networks have been designed to include 500 new access points featuring Ruckus Smart Wi-Fi technology. Each hotel network will be managed through a Ruckus ZoneDirector controller that will manage settings, coordinate channels, optimize wireless power output and ensure seamless roaming throughout the hotel. EthoStream is one of a limited number of Ruckus Top Dog partners in the Hospitality industry.
