

Joe Madison Signs New Multi-Year Deal with SiriusXM

NEW YORK, May 23, 2017 /PRNewswire/ -- Legendary national talk radio host and human rights activist Joe Madison has signed a new exclusive multi-year contract with SiriusXM.



Under the new long-term agreement, "Joe Madison The Black Eagle" will continue to air daily on SiriusXM's Urban View channel 126, 6:00 am – 10:00 am ET, On Demand and through the SiriusXM app.

SiriusXM listeners can expect to hear the renowned host discuss the political news of the day with leading politicians, newsmakers and experts, and challenge his listeners – and himself – to "do something about it." Widely recognized by the talk media industry, Urban View's marquee host has interviewed an impressive roster of top world leaders - including President Barack Obama and Secretary of State Hillary Clinton on multiple occasions – and regularly welcomes Members of Congress, community leaders, diplomats and other notable guests.

A former Executive Director for the NAACP in Detroit, Madison has served on the National Board of Directors of the NAACP and is currently a member of the Board of Governors of the American Red Cross.

Madison was recently named a 2017 nominee for induction into the National Radio Hall of Fame and placed #8 in Talkers Magazine 2017 *Heavy Hundred List*. He joined SiriusXM in 2001.
