

iAnthus Announces Filing of Preliminary Short Form Prospectus

TORONTO, ON and NEW YORK, NY--(Marketwired - October 18, 2017) -iAnthus Capital Holdings, Inc., (CSE: <u>IAN</u>) (CSE: <u>IAN.CN</u>) (CNSX: <u>IAN</u>) (OTCQB: <u>ITHUF</u>) ("iAnthus" or the "Company"), today announced that it has filed a preliminary short form prospectus with the securities regulatory authorities in all provinces of Canada, except Québec, in connection with a proposed "best efforts" public offering of units of the Company (the "Offering").

The Offering will be made through a syndicate of agents led by Canaccord Genuity Corp. and including Beacon Securities Limited, Cormark Securities Inc., Echelon Wealth Partners Inc., and Haywood Securities Inc. (collectively, the "Agents"). The Company has granted the Agents an option, exercisable for a period of 30 days following the closing of the Offering, to arrange for the sale of up to an additional 15% of the units sold under the Offering for market stabilization purposes.

The Offering is subject to customary closing conditions, including regulatory approvals. The Company is proposing to use the net proceeds of the Offering for acquisition financing, other capital projects and general corporate purposes.

The preliminary prospectus is still subject to completion or amendment. A copy of the preliminary prospectus is available under the Company's SEDAR profile at www.sedar.com. There will not be any sale or any acceptance of an offer to buy the securities until a receipt for the final prospectus in respect of the Offering has been issued. The Company will issue a further news release when the Offering size and pricing is finalized.

The securities being offered have not been, nor will they be, registered under the United States *Securities Act of 1933*, as amended, and may not be offered or sold in the United States or to, or for the account or benefit of, U.S. persons absent registration or an applicable exemption from the registration requirements.
