# ProLogis Declares Dividends on Preferred Shares

DENVER, Sept. 4 /PRNewswire-FirstCall/ -- ProLogis (NYSE: PLD), the world's largest owner, manager and developer of distribution facilities, announced today that its Board declared a dividend in the amount of \$1.0675 per Cumulative Redeemable Series C preferred share, payable on October 1, 2007, to shareholders of record on September 14, 2007. Series C preferred share dividends are cumulative and payable quarterly at an annualized rate of \$4.27 per share.

ProLogis' Board also declared a dividend of \$0.4219 per Cumulative Redeemable Series F preferred share, payable on October 1, 2007, to shareholders of record on September 14, 2007. Series F preferred share dividends are cumulative and payable quarterly at an annualized rate of \$1.6875 per share.

In addition, ProLogis' Board declared a dividend of \$0.4219 per Cumulative Redeemable Series G preferred share, payable on October 1, 2007, to shareholders of record on September 14, 2007. Series G preferred share dividends are cumulative and payable quarterly at an annualized rate of \$1.6875 per share.
