

## Interpace Diagnostics Announces Contract with BCBS of Massachusetts

In-Network Access for More Than 3 Million Members

Parsippany, NJ, March 10, 2020 (GLOBE NEWSWIRE) -- Interpace Diagnostics, a subsidiary of Interpace Biosciences (NASDAQ: IDXG) announced today that it has entered into a contract with Blue Cross Blue Shield of Massachusetts with over 3 million members in Massachusetts and across New England. The contract expands Interpace's ThyGeNEXT<sup>®</sup> and ThyraMIR<sup>®</sup> thyroid assays as both covered services and now in-network services for BCBS of Massachusetts' 3 million members and their families. As a result of this Agreement, members of BCBS of Massachusetts can take advantage of the benefits of ThyGeNEXT<sup>®</sup> and ThyraMIR<sup>®</sup> testing due to Interpace's status as an in-network provider. While terms of this Agreement are not disclosed, Interpace now benefits from a claim adjudication perspective as an in-network lab.

Interpace has also successfully achieved positive medical coverage for its services through Medicare as well as other leading National and Regional health plans and is now entering into contracts to confirm such agreements.

According to Jack Stover, CEO of Interpace, "This contract with Blue Cross Blue Shield of Massachusetts continues our trend of establishing improved reimbursement through participation as an in-network provider. I'm pleased to announce that this is the first contract secured by our new VP of Managed Care and Payer Relations, Jeff Salzman."

## About Thyroid Nodules, ThyGeNEXT<sup>®</sup> and ThyraMIR<sup>®</sup> Testing

According to the American Thyroid Association, approximately 20% of the 525,000 thyroid fine needle aspirations (FNAs) performed on an annual basis in the U.S. are indeterminate for malignancy based on standard cytological evaluation, and thus are candidates for ThyGenX<sup>®</sup> and ThyraMIR<sup>®</sup>.

ThyGenX<sup>®</sup> and ThyraMIR<sup>®</sup> reflex testing yields high predictive value in determining the presence and absence of cancer in thyroid nodules. The combination of both tests can improve risk stratification and surgical decision-making when standard cytopathology does not provide a clear diagnosis for the presence of cancer.

ThyGenX<sup>®</sup> utilizes state-of-the-art next-generation sequencing (NGS) to identify more than 100 genetic alterations associated with papillary and follicular thyroid carcinomas, the two most common forms of thyroid cancer. ThyraMIR<sup>®</sup> is the first microRNA gene expression classifier. MicroRNAs are small, non-coding RNAs that bind to messenger RNA and regulate expression of genes involved in human cancers, including every subtype of thyroid cancer.

ThyraMIR<sup>®</sup> measures the expression of 10 microRNAs. Both ThyGen $X^{\mbox{\sc B}}$  and ThyraMIR<sup>®</sup> are covered by both Medicare and Commercial insurers.
