**Tax Status of Distributions**  
**June 30, 2021**

The tax character of the distribution paid by Barings BDC, Inc. (the “Company”) on June 16, 2021 to shareholders of record as of June 9, 2021, is set forth below. For tax purposes, the Company is a regulated investment company (“RIC”) and designates the tax character of distributions paid on June 16, 2021 in accordance with Subchapter M of the Internal Revenue Code of 1986, as amended.

Distributions that were reinvested through the Company’s (or other brokerage firms’) Dividend Reinvestment Plan are treated, for tax purposes, as if they had been paid in cash. Therefore, stockholders who participated in a Dividend Reinvestment Plan should also refer to the table below for appropriate tax treatment of the distribution paid on June 16, 2021.

The amounts shown in the table below represent the estimate of the Company’s distribution paid on June 16, 2021. Distributions paid on June 16, 2021 are classified as follows:
