feedback. Integration of medical company policies and protocols while sending telemedicine sessions on the smart glasses is also possible with Genzõ. Genzõ uses 'HIPAA compliant equivalent' EU-based GDPR-compliant software (ISO27001 and NEN7510) to share (push and pull) medical data safely to and from patient files.

The Vuzix M400 with its enhanced performance and capabilities is the ideal solution to fulfill the urgent needs of our customer case in response to this pandemic," stated Martijn de Groot, CEO and Co-Founder of 1Minuut Innovation.
