

Two Harbors Investment Corp. Announces Second Quarter 2021 Common and Preferred Stock Dividends

(NYSE: TWO), an Agency + MSR mortgage real estate investment trust, today declared a dividend of \$0.17 per share of common stock for the second quarter of 2021. The second quarter dividend is payable on July 29, 2021 to common stockholders of record at the close of business on June 29, 2021.

Two Harbors also declared today the following preferred stock dividends:

- a dividend of \$0.50781 per share of the 8.125% Series A Cumulative Redeemable Preferred Stock;
- a dividend of \$0.47656 per share of the 7.625% Series B Cumulative Redeemable Preferred Stock;
 and
- a dividend of \$0.45313 per share of the 7.25% Series C Cumulative Redeemable Preferred Stock.

The Series A, Series B and Series C preferred dividends are payable on July 27, 2021 to the applicable preferred stockholders of record at the close of business on July 12, 2021.
