It represents a 7.7% increase over the prior quarter of \$.13. The dividend produces an annualized rate of \$.56 per common share and is payable on March 23, 2020 to shareowners of record as of March 9, 2020. The annualized dividend yield is 2.02% based on a closing stock price of \$27.73 on February 26, 2020.
